### REPRESENTATIVE TEAMS GUIDELINES

It is NTJSA policy that any team member selected for any Representative squad is to make themselves available for all scheduled tournaments & training sessions throughout the current season. Once selected all team members are to commit to their squad on all levels.

No Team member will be absent from any training session without notification of a valid reason to the Coach, Team Manager or NTJSA prior to the commencement of training.

**PLEASE NOTE:** In the past the NTJSA have allowed children to compete in other sports which clashed with NTJSA Representative Team training, unfortunately this is not the case anymore the NTJSA will expect full commitment from selected players.

No Team Member will withdraw from any scheduled match without a legitimate explanation to the NTJSA. These include Injury, Illness, Personal Family matters or selection in a higher level soccer team. The NTJSA reserve the right to remove any player from this squad should they be unable to participate in any scheduled tournament match.

It is important to remember that players may not be selected entirely based on their ability. Selection into a Representative team is also determined by the player's commitment to the team, their involvement & participation as a team player and a willingness to abide by all Coach's, Team Managers & NTJSA directions & decisions.

**Should you be unable to comply with any of the rules & guidelines or attend any of the scheduled tournaments set out by the NTJSA for Representative Teams we suggest you reconsider your decision to trial for this team.**
